DIGITAL EXCHANGE ACCESS SERVICE1. GENERAL

Effective 14 July 2024, Digital Exchange Access (DEA) service is destandardized. Requests from new customers for DEA service will not be processed. Existing DEA service customers may make modifications to existing circuits but may not move existing circuits to a different location except within the current building. N

DEA Service provides digital access between the customer's premises or other service point and the Company's Public Switched Telephone Network (PSTN). The access is provided on a DS-1 basis sub-divided into 24 DS-0 time slots at the Company's digital switching systems.

DEA Service uses telephone numbers that conform to the North American Numbering Plan (NANP). As required by Compliance and Enforcement and Telecom Regulatory Policy CRTC 2018-484 (CETRP 2018-484), *Implementation of universal network-level blocking of calls with blatantly illegitimate caller identification*, the customer must ensure that no calls are delivered over this service that do not conform with the requirements of this CETRP 2018-484.

2. SERVICE AND EQUIPMENT

C. DEA service consists of Access, Digital Trunk Controller (DTC) Port, and PSTN Connectivity. D

D

1) Access

The access facility provides the customer with a jack-ended digital local loop from the customer's premises or other service point to the customer's serving Wire Centre within an Exchange. The access facility is only available on a DS-1 basis consisting of 24 DS-0 time slots.

2) DTC Port

The DTC Port provides the connection between the access facility and the PSTN. The DTC Port is available on a DS-1 basis that is subdivided into 24 DS-0 time slots. A DTC Port is required for each DS-1 access facility.

3) PSTN Connectivity

PSTN Connectivity enables the customer to access the local PSTN.

D. Outgoing calling line identification is available as an optional feature. Outgoing calling line identification provides calling name and number information on outgoing calls from the customer's digital exchange access service.

2. SERVICE AND EQUIPMENT

E. DEA Service may be terminated by the customer prior to the expiration of the fixed contract period upon the conditions specified in Article 21 of Item 200 – Terms of Service. The following exceptions apply: (a) a customer may terminate once per year up to two PSTN connections for each contracted DEA Service without any termination charges applying. If the allowance for terminating PSTN connections as stated above is not used during the contract year, then the allowance cannot be carried forwarded to another year, and (b) a customer may convert from DEA Service to other network access services offered by the Company, without paying any termination charges, provided that the monthly re-occurring charges under the new contract are of equal or greater value to those remaining under the customer's existing unexpired contract for DEA Service. Eligible alternative contracted tariffed network access services are Individual Line Business or Multiline Business (Item 475), Centrex (Items 1980, 1982 and 1985), Hosted IP Telephony Service (Item 1988), Megalink Service (Item 2000), SIP Trunking (Regional) Service (Item 2264), and SIP Trunking Service (Item 2270).

F. In addition to the termination charge provisions above, termination charges do not apply in the case of a DEA service customer that migrates all their DEA service accesses which are subject to the terms of an MCP to a new MCP or MCPs for one or more of Individual Line Business Service (Item 475.2) or Multiline Business Service (Item 475.3).
