# DIAL ACCESS FOR RADIO PAGING SERVICE

### 1. GENERAL

Dial Access for Radio Paging Service provides unidirectional access from the Company's switched network to the equipment of a customer providing a radio paging service. The service may be provided on either a direct dial basis or on an overdial basis and is available in Local and Wide Area Access.

### SERVICE AND EQUIPEMENT

- A. Service is provided subject to the availability of suitable facilities required to provide the desired service.
- B. In the case of direct dial access, telephone numbers are provided in blocks of 50 numbers with the customer's equipment responding to the last digits of the telephone numbers.
- C. In the case of overdial access, the customer's equipment responds to an additional digit or digits dialed following the regular telephone number.
- D. The customer must supply and maintain all equipment necessary for receiving the incoming calls from the Company's facilities and transmitting the radio signal. All equipment connected to the Company's facilities must conform to the technical and operational requirements outlined in the most current version of the Company's Interface Standard IS-101, Customer Provided Paging Equipment", which will be made available to customers on advance request. Connection of all equipment to the Company's Overdial Access lines that does not conform to the above stated technical and operational requirements must be made through an appropriate interface device specified by Interface Standard IS-101 and which may be provided by the Company.
- E. A minimum of two incoming trunk lines is required for each paging terminal on direct dial access service. Direct dial access service will only be available from designated Central Offices within designated Exchanges.
- F. Service extended to locations outside of the designated Central Office or Exchange service area may be provided at the discretion of the Company. Such services will be subject to Private Line Voice charges as stated in Item 715.

- 2. SERVICE AND EQUIPEMENT continued
- G. 1) Local Dial Access for Radio Paging Service is available only in the local service area of those Exchanges equipped with suitable facilities. Calls placed to a Radio Paging Access number from outside of the Exchange or Community Calling Service area are charged at the applicable message toll rates.
- 2) Wide Area Dial Access for Radio Paging Service is available through the facilities of a designated Central Office. Message toll rates do not apply to Wide Area Dial Access for Radio Paging Service calls originating in Manitoba and placed to a Radio Paging Access number in Manitoba. Calls placed to a Wide Area Radio Paging Access number from outside Manitoba are charged at the applicable message toll rates. Service is provided subject to a written agreement between the Company and the customer.
- H. The facilities provided in accordance with this Tariff Item are provided exclusively for the provision of one-way tone only, one-way tone and voice or alpha-numeric radio paging. These facilities may be disconnected if it is found they are being used for any other purpose. Enhanced Paging Services such as Voice Messaging, Voice Advertising, Voice Mail and other similar services are not permitted.
- I. When it is necessary to provide special equipment or to incur any unusual expense in order to furnish service, an additional charge will be made.
- J. Message duration shall not exceed 15 seconds.
